² Instead of *International Relations/Peace and Conflict Research* subsequently the German abbreviation “ISFK” is used.

³ **Seminar:** An advanced course on a **Master level** that teaches and provides scientific knowledge. Current problems are being discussed by applying scientific methods. Usually, active participation is mandatory and attendance can be restricted. If you only attend, you will gain 3 ECTS. If you take an exam/paper, you will gain 8 ECTS.

⁴ The course is offered in cooperation with and at the Technische Universität Darmstadt (**TUD**).

⁵ **Übung:** Takes place in addition to a Vorlesung. There will be reviews of the course material as well as preparation for upcoming examinations.

⁶ **Vorlesung:** Lectures illustrate and provide an overview of basic, expert and methodological knowledge regarding a specialized area/field. Lecturers mainly teach content by giving a larger presentation. However they also aim at including student input. Usually, attendance is not restricted.

⁷ **Blockseminar:** A short intensive seminar that takes place in a continuous period of a few days, more rarely for a few weeks. Often, a certain weekday or a half a day as a block time is also offered for several months. Blockseminars may include e.g. laboratory and field exercises, subject-related excursions, post-graduate courses. The examinations are often taken directly at the end of the time block, sometimes they are divided into thematic examination blocks.
